This policy is provided to increase your understanding of how ICBC Enhanced Care, WorkSafe BC and the provincial medical plan (MSP) functions with our billing program.

We do not offer Direct Billing to ICBC. Patients with an active claim will need to submit their invoice through the ICBC Patient Portal for reimbursement.

MSP subsidizes 10 chiropractic, massage therapy, naturopathy, physiotherapy and non-surgical podiatry services, **combined**, per calendar year for persons receiving premium assistance. Patients with valid MSP coverage pay only the balance between the MSP rate and clinic fee.

Both WorkSafe BC and ICBC cover a portion of each visit for patients with an active claim who are within the approved time period. We ask that you inform us of any new or active ICBC or WorkSafe BC claims as soon as possible, as some claims require pre-approval from ICBC or WSBC prior to the first treatment.

CANCELLATION POLICY

The clinic requires 24 hours notice for cancellation of a scheduled appointment. **Failure to provide 24 hours** cancellation notice will result in a \$50.00 fee. Should you need to cancel an appointment after regular clinic hours, you can leave a voicemail or send us an email to avoid the cancellation charge.
